The EoP Amicus shall argue that (a) it will be impossible for Dylan Storm Roof, or the AME victims family members; to get a free and fair trial, if the media abuse their publicity power for Masonic White-Black Power divide and conquer parasitic profiteering; thereby abusing the credibility of the court. The EoP Amicus shall provide an updated version of the argument filed on behalf of among others [Michael Adebolajo and Michael Adebowale](#)¹⁰ and [Beate Zschape](#)¹¹ and [Wouter Basson](#)¹²; namely that Dylann Storm Wolf and many thousands of others, are simply low-level left/right, white/black, Muslim/Christian Ethnic-Conflict foot-soldiers symptoms of the Masonic War is Peace social contract; i.e. Civilized Patriarchy's AnthroCorpocentric Legal Matrix's Control of the Reproduction Human Factory Farming War Economy Racket, and Consumptionism Cultural Colonialism Racket agenda's.

The EoP Amicus shall recommend that the charges against Dylann Storm Roof should be dismissed if Dylan Storm Roof provides the court and National Security authorities; his fully informed consent [unconditional Ecology of Peace cooperator](#)¹³ written agreement Oath.

Put simply the motto of an Ecology of Peace international law social contract can be summarized as following:

Ecology of Peace factual reality simple justice legal language terminology:

Earth is not flat and earth's resources are finite. When humans breed or consume above ecological carrying capacity limits, it results in resource conflict. To sustainably protect and conserve natural resources in accordance to local and national carrying capacity limits; and restrict national and international inter-cultural resource war conflict; humans must implement an international law social contract that restricts all the worlds citizens to breed and consume below ecological carrying capacity limits.

“Thou shalt not promote, legislate, enforce or obey laws which enable human's procreation or consumption to transgress ecological carrying capacity limits.”

“We must legally protect the natural capital foundation of all life for all species; by implementing an Ecology of Peace international law social contract; that limits human procreation and consumption to ecological carrying capacity limits; thereby securing the indefinite existence future of our natural capital foundation and by extension the resource foundation for all responsible freedom cooperating humans from all races, classes, and religions.”

Amicus means ‘A Friend of the Court’.

An Amicus brief is usually filed by an individual not directly involved in the case; or who has information and evidence relevant to the case; or legal principles; which can provide the court with greater context to issues relevant to the case; which have not been brought to the attention of the court by either party; too intent on fighting to win their respective cases; by proving themselves ‘right’ and their opponents ‘wrong’.

As detailed the EoP application for Certiorari in the matter of [Alien v Reporters Committee for Freedom of the Press](#)¹⁷; Amicus filings have substantially affected the development of considerable Supreme Court substantive jurisprudence, figuring prominently in many landmark opinions. Several empirical studies have ascertained that Amicus briefs have significantly influenced the Justices’ determinations to grant petitions for writs of certiorari and the underlying Supreme Court decisions on the merits. Most judges and lawyers think Amicus briefs can provide valuable assistance to the Court in its deliberations; such as presenting an argument or citing authorities not found in the briefs of the parties, and these materials can occasionally play a critical role in the Court's rationale for a decision. Amicus briefs can provide important technical or background information which the parties have not supplied; consequently Amicus participation can critically improve judicial decision-making. Amicus involvement may also enhance court transparency, judicial accountability, and the legitimacy and public acceptability of appellate substantive determinations regarding controversial questions. Promoting Amicus access to courts also fosters important first amendment values, such as freedom of speech and the right to petition.

Attached is a copy of the legal correspondence I attempted to send to Judge JC Nicholson via his Law Clerk: Kate Hendricks [[PDF](#)].

As noted in the transcript of the correspondence:

An individual responded from the katehendricks@gmail.com email address; did not deny her name was Kate Hendricks; but said she did not know who Judge Nicholson was; and was not his law clerk, but lived in New York City. She said I must have copied the email address down incorrectly from the Charleston County Bar association website; without a 'c'; because I had originally incorrectly spelt Kate Hendricks as Kate Hendriks.

I found the original email contact address for Kate Hendricks; including the notification that she was the Law Clerk for Judge JC Nicholson on the Charleston County Bar Association website www.charlestoncountybar.org; on or around 20 June 2015. The Charleston County Bar Association has since revamped their website; and removed the original Lawyers Directory pages; including the Hawk-Hendricks page. It now has a 404 Page not found notice [SS: [15-07-16_CharlestonCoBar_16Jul2015_LawyersDir-Hawk-Hendricks](#)]

I checked on Wayback Machine for copies of the original Charleston County Bar Association: Lawyers Directory and although some of the Lawyers Directory pages were archived, the Hawk-Hendricks page was not archived. So I am unable to confirm whether I copied the Kate Hendricks email address down correctly or incorrectly from the Charleston County Bar Association.

I did a Google search for the katehendricks@gmail.com. It is available on only three websites online. I also did a Google search for a Kate Hendricks in New York City. I found a Kate Hendricks; in New York City; who is a comedienne and sorority member; who calls herself Kate the Wasp [SS: [15-07-16_KateHendricks-Gmail-Com_GoogleSearch_Sites](#); [15-07-16_KateHendricks_KateWasp-DragPrincess-IceBucket-Sorority-SalvationArmyBellRinger-11Jun](#)].

I searched for other email addresses for a Kate Hendricks in South Carolina. I managed to find two other email addresses online; one for Judge Nicholson: JNicholson@sccourts.org; and one for his law clerk: Kate Hendricks: JNicholsonLC@sccourts.org. I found them on Charleston County website, where Kate Hendricks informs the parties counsel of Judge Nicholson's order in the Court of Common Pleas in the matter of: Clara Vance et al v Fundamental Long Term Care Holdings. I then contacted Judge Nicholson's law clerk: Kate Hendricks with the legal correspondence. The email was returned allegedly undeliverable. I checked Email Verify to verify whether the email address was valid; which stated that it was valid. It would appear that somebody was either (a) technically blocking the email from being delivered to Kate Hendricks: JNicholsonLC@sccourts.org; or (b) the email was delivered; but I was informed that it was not; in order to give Judge Nicholson's law clerk: Kate Hendricks plausible deniability to be able to pretend she never received it. I then contacted Judge Nicholson via his own email address with the legal correspondence. The email was also returned allegedly undeliverable. I again checked Email Verify to verify whether the email address was valid; which stated that it was valid. It would also appear that somebody is either (a) technically blocking the email from being delivered to Judge Nicholson: JNicholson@sccourts.org; or (b) the email was delivered; but I was informed that it was not; in

order to give Judge Nicholson plausible deniability to be able to pretend he never received it. [SS: [15-07-16_JudgeNicholson_JNicholson-SCCourts-Org_Verify](#)]

If the emails to Kate Hendricks: JNicholsonLC@sccourts.org and Judge Nicholson: JNicholson@sccourts.org were being technically blocked from reaching their destinations; or delivered but I was falsely informed that they had not been delivered; then it would be by some hacker; I imagine such hacker would be either from: NSA, KGB, MI6 or Mossad.

Please also Note: I said 'I Imagine'; which means it's a working hypothesis; not a fact.
